Complete & return application with money order or check payable to Pinehurst Business Partners.

Spaces are limited. Santa's committee will provide notification of acceptance no later than June 20, 2018.

DISPLAY SPACE:

- 1. Booth space size is 10ft x 10ft and is located on the grassy lawn of Tufts Memorial Park.
- 2. All exhibitors must furnish their own display equipment and provide any necessary protection for the elements.
- 3. Exhibitors are expected to remain with their assigned space & keep their area neat at all times.
- 4. Exhibitors are responsible for setting up, maintaining, & removing booth, your merchandise and your trash.
